

Assumption of the Risk, Waiver and Release of Liability Relating to Coronavirus/COVID-19

I acknowledge the contagious nature of Coronavirus/COVID-19 and that it is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and CDC and other health agencies still recommend social distancing.

I further acknowledge that DYSA has put in place guidelines and protocols to reduce the spread of Coronavirus/COVID-19; however, DYSA Coaches/Staff cannot guarantee that you or your family member(s) will not become infected with COVID-19. Further, attendance at conditioning (practices) and friendlies (games) could increase your risk and your family's risk of contracting COVID-19.

I acknowledge the contagious nature of COVID-19 and voluntarily assume all risks that my registered player(s), family and I may be <u>exposed to or infected</u> by COVID-19 by attendance at conditioning (practices) and friendlies (games) and that such exposure or infection may result in known and unknown dangers that are associated with any exposure to COVID-19, including, but not limited personal injury, suffering any type of medical condition, illness, permanent disability, and death;
- I acknowledge that participation at conditioning (practices) and friendlies (games) could result in <u>contracting</u> COVID-19, respiratory failure, death, and/or the transmission of COVID-19 to family or household members and others who may also suffer these effects;
- 3. I acknowledge that the risk of becoming exposed to or infected by COVID-19 <u>may result from the actions, omissions, or negligence</u> of my child, myself and others, including, but not limited to, DYSA coaches, volunteers, its players, parents, contractors, agents, and other affiliates;
- 4. On behalf of myself and my family, I knowingly and voluntarily waive, release, covenant not to sue, and forever discharge, and agree to indemnify and hold harmless, DYSA, its coaches, volunteers, its players, parents, contractors, agents, and other affiliates, and its and their respective officers, directors, members, representatives, successors and assigns (the "DYSA Parties") from any and all liability, damages, losses, suits, demands, causes of action (including, without limitation, negligence), or any other claims of any nature whatsoever, arising out of, or relating in any way to, your use of and/or participation in the programming of DYSA and any potential or actual exposure to COVID-19, to the maximum extent permitted by law; and

5.	I agree to <u>abide by</u> the COVID-19 <u>DYSA guidelines and protocols</u> AND COVID-19 <u>directives and guidelines in effect in the stated counties and communities</u> where conditioning (practices) and friendlies (games) may take place.
